

## Riding Program: High Country Equestrian Center Winter-Spring session 2021

### Program description:

The session will run for 17 weeks from January 11th - June 5th 2021

Program Cost: \$1054.00 per rider (Plus GST) Total: **\$1106.70**

No lessons: (Feb 13-19, March 27-April 9, May 22-28)

2 to maximum 5 riders per class running for +/- 45 min

**Please contact us for available lesson times. Availability is limited, lesson spaces will not be confirmed until registration and payment has been received.**

- ❖ All riders must wear a boot or shoe with a heel and **horse-back** riding helmets are mandatory.
- ❖ Payment options:
  - Full payment made at time of registration \$1106.70
  - Instalment payments. The registration fee of \$221.34 must be made on the day of the registration, the first payment of \$221.34 must be made on the day of the session start date, second payment on the 1<sup>st</sup> day of February, the third payment on the 1<sup>st</sup> of March and the fourth payment on the 1<sup>st</sup> of April. If the registration is submitted the day session starts or later, the registration fee and the second payment must be made the same day.
- ❖ Package must be paid in full at time of booking and is non-refundable and non-transferable.
- ❖ Cash or cheque made payable to High Country Equestrian Center, or an e-transfer sent to [office.hcequestriancenter@gmail.com](mailto:office.hcequestriancenter@gmail.com)
- ❖ All participants are required to have a Release of Liability Waiver signed prior to having contact with the horses and COVID-19 Liability Waiver signed before entering facility.
- ❖ Students in all programs are expected to arrive a minimum of 15 min prior to their lesson to catch, groom and tack their horse.
- ❖ Cancellation policy:
  - If rider is unavailable to make their scheduled lesson for any reason, HCEC is unable to offer refunds, credits or make up classes.
  - If a scheduled lesson is cancelled due to inclement weather conditions HCEC will offer one make up class over a specific period of time. If student is unable to attend a scheduled make up class, HCEC will not provide refunds, credits or make up classes.
